PENDING CONSIDERATION

District Cllr. Clementson advised he had spoken to the officer who was of the opinion that there was insufficient evidence to trigger the requirement for an Environmental Impact Assessment, though a formal decision is yet to be made.

County Cllr. Montyn reported:

- The Madestein application Highways attitude marked a change in highways response to planning applications.
- He had been discussing National Planning Policy Framework 32 with the officers.
- The officers had agreed to investigate the cumulative effect of the traffic on the length of the A286 including each roundabout up to and including the A27 junction. This report would include all the planning applications that had been permitted since April 2012, and those applications that were currently going through the appeal process in addition to this the figures would be uplifted by 30% for the summer months.
- The officer had requested the Highways Agency make comments on application.
- The applicant would pay for the traffic consultants report.
- He advised the Parish Council to make comments directly to the County Council on highways when the application is submitted. On the suggestion of Cllr. Clementson an approach would be made to the WSCC Highways staff to request a pre-application meeting.
