On a proposal by the Chairman it was RESOLVED to object due to the lack of clarity of the information provided it was agreed to reconsider the councils position if the following concerns were addressed:

- The drawings do not provide any information on the current property on the site. Therefore, the Council were unable to compare the scale of the building in relation to the current property. Concern was expressed as to the bulk and scale of the proposed building.
- The building would alter the street scene.
- Plans are inaccurate showing only three of the five existing gas cylinders. These gas cylinders serve other properties in the same development...
- The plan appears to show the proposed development being built on top of the existing gas cylinders.
- The turning area is compromised and would hinder the delivery of the gas.
- No information to advise as to why the curtilage was being enclosed which appears to be highway land.
- Height of building in relation to the height of the existing overhead electrical cables which are very low at this site.
