A breach of planning control has been identified and the landowner has been advised to submit a planning application. Following a request for an update on the planning application the following response was received;

The use of the building has proceeded without adverse impact. It provides employment for two individuals at the premises and although it is located in a remote location away from the settlement of East Wittering it is accessed directly from drove Lane which serves a holiday camp, a farm/storage place and a couple of dwellings. For these reasons it cannot be said to be isolated. The use in part relies on parking on land to the side and an outside toilet. These are not intrusive and overall no complaint has been made about the function of the building for small business purposes. In light of these considerations; there is no public interest in pursuing the matter further and it is proposed that the file be closed. A report will now be written to bring this matter to a close.

On a proposal by the Chairman, it was RESOLVED to write to Chichester District Council expressing concern that the District Council had previously stated that planning permission was required on this site confused by the correspondence received whether it needs planning consent.
