The Parish Council strongly believes the whole community should be involved in decisions affecting them and their neighbourhood and in shaping the future of their parish.

	Agenda, minutes, meeting schedules and contact details are posted on the three parish council notice boards as well as uploaded to the Parish Council website as required under the Local Government Act 1972. Minutes of all Council meetings and its Committees are available at the Witterings Public Library
	Informative leaflets are available from the parish clerk on request and are brought to the meeting for distribution to members of the public who attend and can also be downloaded from the website. New leaflets will be added as necessary.  Consulting all parishioners on important issues will be key to
	the strategy. It will ensure those most affected can put forward an opinion and given an opportunity to fully participate.

	Ensuring Consultations include all members of the parish by identifying the hard to reach groups. This may require establishing different engagement channels for them, such a visiting the School, Nursery, Youth Club and the British Legion in neighbouring villages				
	Support local projects and participate in local events  Support local organisations and engaging with them and assisting them in meeting their own aims and objectives				
	The Parish Annual Meeting is the ideal opportunity to bring the community together and allow residents to question and review how the elected members help shape the community. The Parish Council should determine the "interest theme" for each annual meeting to encourage maximum turn out by the community. The main objective of the annual meeting must be to provide and encourage two-way communication between the community and Councillors				
To manage the Council's resources wisely	Have good financial control through legal procedures and quality auditing to ensure that resources are spent on the needs of the community
