Any new applications for proxy votes or changes to existing proxy votes must reach the Returning Officer at East Pallant House, East Pallant, Chichester, West Sussex, PO19 1TY by 5pm on Wednesday, 24 APRIL 2019 to be effective for this election.
5. The last date and time for the receipt of an unforeseen medical emergency proxy vote is 5 pm on THURSDAY, 2 MAY 2019.
